Matters Arising:

All Saints Church School House Boundary Wall:

Mr David Kitching, Managing Director of 'Stress', has been chased by the Clerk for possible solutions.

Barnsclose – South West Water Works (SWW):

There exists a covenant to maintain the site as a children's' playing field. Site meeting to be held this afternoon at 12.00 with representatives from SWW. Issues of concern to be raised:

- 1) Size of vehicles which will use the track? & for what purposes?
- 2) How often will large vehicles use the access road?
- 3) Require comprehensive plans and proposals which will retain the existing size of the recreation grounds and provide all the current play equipment.
- 4) What safety measures will be put in place to protect the public?
- 5) Will the access road be locked/restricted?
- 6) Confirmation that local residents will be fully consulted.
- 7) That all legal costs will be covered by SWW.
- 8) The site will be reinstated and fully maintained.

Members acknowledge that the wet weather has hampered the ongoing works.
